Exhibitor information and instructions:

Women's World will be held in the Centennial Building adjacent to the Cox Pavillion (Commercial exhibits) and will be open free of charge to all persons in attendance at the NSRA event.

EXHIBIT DATES AND HOURS:

Friday	April 13 th 2011	9a.m. until 5p.m.
Saturday	April 14 th 2011	9a.m. until 5p.m.
Sunday	April 15 th 2011	9a.m. until 3p.m.

The exhibit buildings will be open to the general public at 9:00 a.m. each morning and will close at 5:00 p.m. Friday, Saturday and 3:00 p.m. on Sunday. The building's exhibitor door will open at 8:30 a.m. each morning for exhibitors with proper credentials only. This will allow exhibitor to re-stock and ready their booth and area prior to opening. The Centennial Building will be locked securely upon our departure each night. The doors will be locked promptly at 5:00 p.m. so be ready to pack up and leave at that time. You must be out of the building by 5:10p.m.

BOOTH SIZES AND FEES:

All spaces are 10 feet by 10 feet - \$135.00

Corner spaces are an additional - \$25.00

Complementary electrical and tables (Contact us for specifics)

(If you need more than 100 square feet, please apply for more spaces.)

We will have a "daily car number giveaway". You will receive 3 cards on set up day with three different car numbers. Please post one card each day. The Street rodders will come in every day, looking at every booth to see if their number is posted. You may give away anything of your discretion as long as it does not violate the terms of your contract. This is a wonderful promotion of Women's World and creates a lot of traffic.

The Women's World director may assign and or change location without notice to the exhibitors/vendors in order to accommodate space that may be needed in the best interest of the show and the NSRA. Submission of a space agreement and payment for spaces does not guarantee that the space will be assigned. NSRA Women's World director reserves the right to determine the eligibility of any vendor to be included in the event, either before or after proper execution of this agreement.

SETUP AND BREAKDOWN:

IF ALLOWED TO DRIVE IN, YOU WILL BE GIVEN 1 HOUR TIME PERIOD TO UNLOAD AND REMOVE YOUR VEHICLES FROM THE BUILDING. THEN START SETTING UP YOUR DISPLAY!!!!

Booth setup will be on Thursday April 12th from 9 a.m. until 6 p.m. **All displays must be completed by 6 p.m.** Security is provided Thursday through Saturday night. Participants will receive their passes and parking permits on Thursday morning when you check in. Booths may be dismantled at 3 p.m. (NOT BEFORE) on Sunday April 15th. No vehicles are allowed to enter until 3:30 p.m. or until told to do so.

EQUIPMENT AND APPEARANCE:

You are responsible for your own display including backdrop. No canopy tops are allowed. Everyone's cooperation is essential in presenting a professional image. Please be considerate of your neighbor and do not obstruct vision or accessibility to your neighbor's booth. Absolutely no displays in aisle are allowed. There is no smoking and no pets are allowed in all buildings of the Oklahoma State Fair Park.

ADMISSIONS TO THE GROUNDS:

Your registration fee includes two admission buttons and one vehicle pass to the grounds per vendor. You must purchase additional buttons and passes if needed. Beginning Friday morning you will need vehicle pass and admission button for entry into the Fair Park.
